Moor Road update – an update is still awaited from North Yorkshire Council in respect of both the flue structure and possible further work to improve drainage

Road down to Preston Mill – The vegetation around the safety marker posts along Mill Hill has been strimmed. North Yorkshire Council have advised that in accordance with their policy, they will not cut back overgrowth along the verges in general. (Their policy with regard to minor roads which do not ordinarily receive any routine maintenance of grassed verges other than to keep signs and other street furniture clear and also at side road junctions where visibility splays for emerging drivers need to be maintained).

Oak Tree on Light Lane – the tree has been inspected by the Head Woodman at Bolton Estate and The Estate are arranging for a further branch to be removed in the interests of safety.

Cemetery – the railings and gate at the cemetery have been refurbished and repainted.
