Grass Cutting - Light Lane and Cemetery Extension – the decisions made by the Parish Council at its last meeting have been implemented. This has resulted in a saving of £10 per cut in the cost of cutting the grass in the Cemetery Extension.

Grit Bin in the Village Centre – North Yorkshire Council have agreed to replace the grit bin which was damaged by their Refuse Collection Vehicle.

Locality Grant – North Yorkshire Council has authorised the payment of a grant of £400 from Councillor Sedgwick's Locality Budget towards the cost of implementing measures to improve Biodiversity in the area of the Cemetery Extension

Moor Road update – in relation to the marking up of the route of the old lead flue where it passes under Moor Road, North Yorkshire Council has confirmed that the Structures Team are currently looking at a scheme. The proposed scheme is currently under development and more details will be provided in due course.

BT Payphone – the Parish Council has been advised that BT have decided not to remove the Village Payphone.
