Trees in The Stanney: The Clerk wrote to the Bolton Estate who have advised that whilst the Forestry Commission usually grants felling licences within 3 months, there are currently delays in dealing with them. The Estate has approached a contractor to undertake the work, which it is hoped will be completed shortly after the Estate receives permission. Further details will be provided to the Parish Council when available.

Potholes in the Village: These were reported and have been patched

Village Signage: This matter was raised with County Council Officers by County Councillor Sedgwick and will be considered.

Quarry: A zoom meeting with the Quarry Manager and Mr Steve Carter has been arranged for 30 June – outcomes from that meeting will be reported orally

Village Hall – sound baffles: the Village Hall Committee has discussed this issue raised at the recent Village Meeting and is in the process of ascertaining costings and researching various solutions. The Parish Council will be kept updated

Village Play Area:

- (1) The Village Hall Committee has discussed the seating in the play area and is in the process of ascertaining costings and researching various solutions. The Parish Council will be kept updated.
- (2) Richmondshire District Council has supplied the Clerk with the most recent Play Equipment Inspection report and has confirmed that it will only maintain any play item within the play area and the boundary etc. Any other item placed in there is Parish responsibility. RDC have advised that there are no major issues with the play items, and that they are working with pest control to try and find a safe and suitable answer to the rabbit issues.

Village Emergency Plan:

- (1) The Clerk has written to the North Yorkshire Resilience Forum to ask if they would be prepared to attend a meeting to brief Councillors and residents further – a response is currently awaited
- (2) Councillor Sayers has attended a training session on Resilience Planning organised by the YLCA
